Population¹

- Villa Park is the 34th most populous city in Orange County: 5,812
- Villa Park has the 33rd greatest youth (0-17) population when compared to other OC cities: 1,164
- Ethnic breakdown: 71.9% White; 10.3% Hispanic; 14.6% Asian; 0.7% Black; 2.5% Other
- Median Family Income: \$165,833 ([Orange County: \$85,009] [U.S. Census Bureau: 2011 American Community Survey 5-Year Estimates])

Social Services

- Villa Park children receiving financial assistance through CalWORKs²: 16
 - Representing -3.44% of the 46,429 child recipients county-wide (12/1/2011)
- Child Abuse and neglect reports on children received from Villa Park in 2013: 18
 - Representing 0.0% of the 39,594 reports received county-wide

Child Abuse and Neglect Report Details

- The majority of the 18 reports came from mandated professions (94%); Counselor/Therapist (6%), School Personnel/Teachers (12%), Other Professionals combined (41%), Law Enforcement (6%), and SSA, Probation, other Government Agency (35%). Non-mandated but concerned parties (including relatives) made 1 reports, equal to 6% of the total.
- The 18 report-allegations represent 16 distinct children³ in Villa Park, by Gender & Age:

Extended Foster Care (EFC) Program: Non-Minor Dependents

- The EFC Program, created by Assembly Bill 12 in January, 2012, allows foster youth to receive foster care benefits and services after age 18 and up to age 21. These young adults remain under the jurisdiction of the court and supervision of the county as they transition to independence.
- There are 1 Non-Minor Dependents residing within the city of Villa Park as of 12/31/2013

How can the Villa Park Community help to Preserve and Reunite their Children and Families?

- Support community-based responses to protect children and preserve families
- Become a resource family and encourage others to do so (short or longer term foster care)
- Participate in team decision making meetings that bring together people to help children at risk
- Provide space for foster care orientation, training or family visitation
- Help with community mentoring for birth parents working towards reunification
