Population¹

- Fountain Valley is the 19th most populous city in Orange County: 55,313
- Fountain Valley has the 22nd greatest youth (0-17) population when compared to other OC cities: 11,643
- Ethnic breakdown: 49.2% White; 13.1% Hispanic; 33.1% Asian; 0.9% Black; 3.7% Other
- Median Family Income: \$91,003 ([Orange County: \$85,009] [U.S. Census Bureau: 2011 American Community Survey 5-Year Estimates])

Social Services

- Fountain Valley children receiving financial assistance through CalWORKs²: 288
 - Representing 0.62% of the 46,429 child recipients county-wide (12/1/2011)
- Child Abuse and neglect reports on children received from Fountain Valley in 2014: 460
 - Representing 1.0% of the 46,069 reports received county-wide

Child Abuse and Neglect Report Details

- The majority of the 460 reports came from mandated professions (89%); Counselor/Therapist (27%), School Personnel/Teachers (25%), Other Professionals combined (27%), Law Enforcement (15%), and SSA, Probation, other Government Agency (7%). Non-mandated but concerned parties (including relatives) made 49 reports, equal to 11% of the total.
- The 460 report-allegations represent 341 distinct children³ in Fountain Valley, by Gender & Age:

Extended Foster Care (EFC) Program: Non-Minor Dependents

- The EFC Program, created by Assembly Bill 12 in January, 2012, allows foster youth to receive foster care benefits and services after age 18 and up to age 21. These young adults remain under the jurisdiction of the court and supervision of the county as they transition to independence.
- There are 1 Non-Minor Dependents residing within the city of Fountain Valley as of 12/31/2014

How can the Fountain Valley Community help to Preserve and Reunite their Children and Families?

- Support community-based responses to protect children and preserve families
- Become a resource family and encourage others to do so (short or longer term foster care)
- Participate in team decision making meetings that bring together people to help children at risk
- Provide space for foster care orientation, training or family visitation
- Help with community mentoring for birth parents working towards reunification
