



# Social Services in Dana Point

## Population<sup>1</sup>

- Dana Point is the 27th most populous city in Orange County: 34,003
- Ethnic breakdown: Asian 4.1%, Black 0.9%, Hispanic 16.7%, White 75.7%, Native American 0.4%, Other 2.2%.
- Dana Point has the 28th greatest youth population (0-17yrs) when compared to other OC cities: 6,019
- Median Family Income: \$105,578 ([Orange County: \$86,003])

## Social Services<sup>2</sup>

- Dana Point children receiving financial assistance through CalWORKs: 80
- Representing 0.2% of the 38,505 child recipients county-wide (1/2016)

## Child Abuse and Neglect Report Details

- Number of children reported for abuse and neglect from Dana Point in 2016: 331
- Representing 0.68% of the 48,732 reports received county-wide
- The majority of the 331 reports came from mandated professions (90%); Counselor/Therapist (29%), School Personnel/Teachers (24%), Other Professionals combined (29%), Law Enforcement (10%), and SSA, Probation, other Government Agency (8%). Non-mandated but concerned parties (including relatives) made 33 reports, equal to 10% of the total.
- The 331 reported-allegations represent 239 distinct children in Dana Point, identified below by Gender & Age:

**Extended Foster Care (EFC) Program: Non-Minor Dependents**

The EFC Program, created by Assembly Bill 12 in January, 2012, allows foster youth to receive foster care benefits and services after age 18 and up to age 21. These young adults remain under the jurisdiction of the court and supervision of the county as they transition to independence.
