Extended Foster Care (EFC) Program: Non-Minor Dependents⁵

The EFC Program, created by Assembly Bill 12 in January, 2012, allows foster youth to receive foster care benefits and services after age 18 and up to age 21. These young adults remain under the jurisdiction of the court and supervision of the county as they transition to independence.

There are 0 non-minor dependents residing within Laguna Woods as of 12/31/2017.

How can the Laguna Woods Community help to Preserve and Reunite their Children and Families?

- Support community-based responses to protect children and preserve families.
- Became a resource family and encourage others to do so (short or longer term foster care).
- Participate in team decision making meetings that bring together people to help children at risk.
- Provide space for foster care orientation, training or family visitation.
- Help with community mentoring for birth parents working towards reunification.
